Battery USA, Inc. will assign you a maximum credit line and has the right to reduce or withdraw your credit privileges under this agreement at any time without prior notice and/or without cause except as otherwise provided by law.

Battery USA, Inc. may permit you to purchase goods and/or service from Battery USA, Inc. on credit up to your credit line. You agree that said purchases will be governed by the terms of this CREDIT AGREEMENT. It is further agreed and stipulated that the receipt and presentment of this application to Battery USA, Inc. for purposes of venue, any and all litigation that may become necessary, be brought by either party hereto, shall be brought in Polk County, Florida.

Invoices will be issued by Battery USA, Inc. for purchases made under this CREDIT AGREEMENT. Payment of the purchase price shall be made pursuant to the terms set forth on each invoice. Battery USA, Inc. may require you to sign for the invoice at the time of ordering a credit purchase or at the time of delivery of the goods or services ordered.
